<b>A: Professional Learning Grant for remote</b>	LTANT members residing in remote areas to attending professional learning.  LTANT members traveling to remote areas for professional learning.	<b>\$800</b>	Conference fees, relief teacher costs, transport, accommodation	Recipients must prepare a short written report (500 words) on their learning to be shared on the website/Facebook or facilitate a mini-PD session for LTANT members.	4
<b>B: Professional Learning Grant for interstate PD</b>	LTANT members who are currently working as full-time or part-time teachers NB: Only one teacher per school/institution is eligible to apply for this grant	<b>\$800</b>	Conference fees, relief teacher costs, transport, accommodation	Recipients present their learning at the annual LTANT conference in August.  <i>If they are unable to attend this date they must facilitate a mini-PD for LTANT members.</i>	6

### Conditions of application

1. Applicant must be a current LTANT member (membership expiring 28 Feb 2026).
2. LTANT members are only eligible to receive one grant.
3. PL Grant recipients are required to fulfill the conditions of the 2025 LTANT PL Grant for which they have applied.
4. Committee will consider all applications. As successful PL Grant recipients must share their knowledge with other members, the committee will aim to ensure a range of conferences are accessed.
5. For relief teacher costs, your school may submit an invoice for up to \$270.
6. Members who have not fulfilled grant requirements from previous years will not be eligible to apply for future grants. The committee reserves the right to consider past compliance when reviewing applications.
